## **BRIEF OVERVIEW OF THE FIRM’S PRACTICE AREAS**

### **ARBITRATION:**

The Firm has a large arbitration practice which includes both domestic as well as international arbitrations. The Firm has represented various large conglomerates in ad-hoc arbitrations, institutional arbitrations as well as arbitrations held under the aegis of various stock exchanges on disputes pertaining to turn-key projects, commercial & infrastructure contracts, maritime disputes, real-estate projects, etc. The team is well-equipped to advise and represent clients in arbitral proceedings from start to finish and works with external counsel and domain experts on a need basis. ### **BANKING & FINANCE:**
